## Why firms send us their dental cases

## The process, in five steps

- **1. Send the case over.** Email Dr. Dillon or call our office with the client's name and a brief description. We confirm within 1 business day and send intake and LOP paperwork.
- **2. Comprehensive exam and imaging.** A thorough exam with digital X-rays, CBCT 3D imaging, and intraoral photos — all documented and time-stamped.
- **3. Itemized plan and narrative.** A written treatment plan with CDT codes and fees, plus a plain-language narrative connecting the findings to the reported injury.
- **4. Treatment under the signed LOP.** We complete care with no payment sought from the client while the case is pending; the balance is protected until settlement.
- **5. Settlement documentation and billing.** Final records, before-and-after imaging, and an itemized statement ready for your file. We handle reductions professionally when warranted.

## Who handles your cases

**Dr. Matthew Dillon, DDS, MAGD, FICOI** personally oversees every LOP case — exam, plan, and narrative all carry his review and signature. Undergraduate degree, University of Florida; DDS, NYU College of Dentistry; advanced training, Kois Center. He holds a Mastership in the Academy of General Dentistry (MAGD) and is a Fellow of the International Congress of Oral Implantologists (FICOI). His clinical focus is comprehensive diagnostics — identifying the full extent of an injury and documenting it defensibly before planning treatment — exactly what dental-trauma cases require.

## What your file receives

- Signed Letter of Protection and completed intake.
- Comprehensive, dated exam findings.
- Full imaging — digital X-rays, CBCT 3D, and intraoral photographs.
- Itemized treatment plan with CDT codes and fees.
- Signed narrative report linking findings to the reported mechanism of injury.
- Final records at completion: progress notes, before-and-after imaging, and an itemized settlement statement.
